NEW VEHICLE PROTECTION

Paint Sealant : In the event, for a period of three (3) years from the date of application that the exterior surfaces treated with EnviroSeal paint sealant should be damaged by weather induced oxidation, fading, acid rain, bird droppings, tree sap, industrial fallout, or the exterior chrome surfaces shall become corroded, EnviroSeal will repair the affected surfaces of the vehicle.

USED VEHICLE PROTECTION

Paint Sealant : In the event, for a period of three (3) years from the date of application that the exterior surfaces treated with EnviroSeal paint sealant should be damaged by weather induced oxidation or fading, EnviroSeal will repair the affected surfaces of the vehicle.

CLAIM PROCEDURE

The purchaser must present a copy of this warranty at the time of filing a warranty claim. The vehicle owner must report any damage within fifteen (15) days following the occurrence of any damage covered by this warranty by contacting EnviroSeal at the phone number shown below. Failure to report damage within fifteen (15) days following occurrence will relieve EnviroSeal all legal responsibility under this warranty. No repairs will be paid by EnviroSeal unless authorized in writing prior to being repaired. EnviroSeal reserves the right to inspect any damaged area prior to authorizing any repairs. Should the named original owner move or should the authorized dealer be unavailable, the original owner must contact EnviroSeal.

EXCEPTIONS AND EXCLUSIONS

This limited warranty does not apply to:

1. Damage caused by acts of abuse, vandalism, flood, fire, wind, lightning, hail, acid rain, alteration, stone or sand abrasion, misuse, negligence, or anything other than natural causes, or any causes that EnviroSeal deems as misuse.
2. Damage to surfaces which have been repaired or replaced unless treated with the original protective product, or to mechanical parts and exhaust systems.
3. Damage as a result of vehicle manufacturer defects or damage covered by vehicle manufacturer warranty.
4. Damage or deterioration caused by alteration, resurfacing, painting or washing of the painted surface with a solvent, abrasive, or acid which would cause the removal of the paint sealant.
5. Any finished surface which is not damaged. Note : Should the repairer of damaged surface be unable to exactly match the color, quality, or style of any undamaged surface, EnviroSeal shall pay only for the repair of the damaged surface and will not pay for the repairing and/or repainting of the undamaged surface.
6. Surface rust.
7. Graphics or decals.

CONDITIONS AND LIMITATIONS OF LIABILITY

EnviroSeal shall not be liable for contingent or consequential damage not expressly provided for above and all damages recoverable are hereby limited to the cost of repair of any defects. This limited warranty is expressly in lieu of all other warranties, expressed or otherwise. No implied warranty or merchantability or fitness for particular purpose shall apply for a time beyond the length of any expressed warranty made herein. This limited warranty gives original owner specific legal rights. You may also have other rights which vary from state to state. Some states do not allow the exclusion or limitation of incidental or consequential damages, or do not allow limitations on how long an implied warranty lasts. Maximum total payout of claims for the EnviroSeal limited warranty is five thousand dollars. Initial application of EnviroSeal must be applied within thirty (30) days of original purchase date.

DEFINITIONS

A New Vehicle is defined as having less than 3,000 miles odometer reading at the time of contract purchase. A Used vehicle is defined as having over 3,000 miles and/or current model year minus 3 model years prior at time of contract purchase.
