GENERAL TERMS, LIMITATIONS, EXCLUSIONS AND CONDITIONS

The warranties contained herein do not apply in any respect to surfaces, materials or areas of the vehicle that have been altered, modified, repaired or changed in any way from manufacturers original condition.

The provisions under these warranties apply only to the affected areas and at no time apply to any other surfaces, sections or areas of the vehicle except that which is directly involved. Customer shall not recover any form of consequential or incidental damages not expressly provided for herein and all damages recoverable by the customer are hereby limited to the cost of the repairs. The warranties contained herein provide for only the repair of the affected area(s) and at no time is it construed to be the warrantor's responsibility to match the color(s) of the unaffected areas of the vehicle. These warranties cover only the repair and/or cleaning of the affected area(s) and makes no provision for any liability on behalf of the warrantor for any consequential damages, direct or indirect.

The warrantor reserves the right to inspect the vehicle in question and obtain verification documents. No one but the warrantor and/or its approved representatives can assume liability for the warrantor, and reimbursement in any form will not be made unless written approval from the warrantor has been issued before commencement of work.

This warranty does not apply to R.V.'s used commercially. For the purpose of this warranty, a commercial R.V. vehicle is any vehicle which is used, wholly or in part, for a commercial purpose.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, AND NO ONE IS AUTHORIZED TO ASSUME FOR ENVIROSEAL, ANY OTHER LIABILITY IN CONNECTION WITH THE SALE OF THESE PRODUCTS. ENVIROSEAL SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL OR INDIRECT DAMAGE OF WHATEVER KIND, AND SHALL ONLY BE REQUIRED TO PERFORM THE REMEDIES LISTED HEREIN.

The warrantor shall not be held liable for any manufacturers defects and/or defects which would and should be covered under the dealers inspection made by the manufacturer's agent or representative.

This EnviroSeal Fabric Restoration Warranty does not apply to stains caused by items other than those listed on the above contract. Nor does it apply to defective manufacturing, improper installation of material, improper application of product, damage, dirt, material which is torn, mishandled or subject to neglect. Further, this warranty does not apply to wood, vinyl, leather, suede, plastic, or damage by causes beyond EnviroSeal's control, or acts of God. This warranty specifically does not cover stains cause by acids, including vomit, dyes, inks, bleaches or corrosives, or fabric that become soiled from everyday use. NOTE: Two year protection for recreational vehicle carpets.
